OFFICE ORDER

On the basis of interview & recommendation of the committee vide dated 11/10/2018, the competent authority is pleased to engage the services of Dr. (Mrs.) Vani Ahluwalia, 2006, Wright Town, Jabalpur as Medical Officer on contractual basis on a fixed honorarium @ Rs. 25,000/- (Rs. Twenty Five thousand only) per month with deduction of Income Tax as applicable, on the following terms & conditions:-

1. Period of engagement will be for a period of three months or till formal alternate arrangements are made, whichever is earlier.
2. The engagement is purely on contractual basis and will not confer any right for regular appointment in any case.
3. Period of engagement will be further extendable as may be required by the employer.
4. The Medical Officer will attend the Institute dispensary at TFRI campus from Monday to Saturday without fail. The duty hours will be from 16:00 to 19:00 hrs at TFRI dispensary. She will also attend TFRI employees/families who may seek medical attentions beyond 19:00 hrs at her clinic, without any extra charges as agreed.
5. Six days leave is admissible during the period of three months. Balance of leave if any cannot be carried over in case of extension of the period. Leaves beyond admissibility will be without pay.
6. The engagement order may be cancelled by the employer at any time without assigning any reason thereof.
7. In case of resigning/leaving of the assignment, one month advance notice will be required for consideration.
8. The offer is valid for seven days from the date of receipt of the order.
