आदेश/ORDER

जिला आयुक्त एवं प्रधान जनगणना अधिकारी , जोरहाट द्वारा जारी आदेश संख्या CENSUS/01/2026-27/Part/47 दिनांक 20 जुलाई, 2026 (प्रति संलग्न) में निहित निर्देशों के अनुपालन में, जनगणना 2027 के आयोजन के संबंध में, यह निर्णय लिया गया है कि अगले आदेश तक इस संस्थान के किसी भी कर्मचारी को किसी भी प्रकार का अवकाश स्वीकृत/प्रदान नहीं किया जाएगा, क्योंकि जनगणना से संबंधित कार्यों एवं अन्य संबद्ध गतिविधियों के लिए अधिकारियों/कर्मचारियों की उपलब्धता सुनिश्चित किया जाना आवश्यक है।

In pursuance of the directions contained in the order issued by the **District Commissioner & Principal Census Officer, Jorhat**, vide **Order No. CENSUS/01/2026-27/Part/47 dated 20th July, 2026** (copy enclosed), regarding the conduct of **Census 2027**, it has been decided that **no leave of any kind shall be granted to any employee of this Institute until further orders**, in view of the requirement of ensuring the availability of officers/officials for Census-related duties and associated activities.

1. तदनुसार, कर्मचारियों को पूर्व में स्वीकृत/प्रदान किए गए वे सभी अवकाश , तत्काल प्रभाव से निरस्त माने जाएंगे। संबंधित कर्मचारी सक्षम प्राधिकारी के निर्देशानुसार अपने कर्तव्य पर उपस्थित होंगे।

Accordingly, **all leaves already sanctioned/granted to the employees, shall stand cancelled with immediate effect.** The concerned employees shall report for duty as per the instructions of the Competent Authority.

2. सभी कर्मचारियों को निर्देशित किया जाता है कि वे उपर्युक्त निर्देशों का कड़ाई से अनुपालन सुनिश्चित करें। उक्त अवधि के दौरान अवकाश हेतु किसी भी अनुरोध पर विचार नहीं किया जाएगा , सिवाय असाधारण परिस्थितियों के, जिसमें सक्षम प्राधिकारी की पूर्वानुमति तथा जिला आयुक्त एवं प्रधान जनगणना अधिकारी , जोरहाट द्वारा जारी निर्देशों का अनुपालन आवश्यक होगा।

All employees are hereby directed to strictly comply with the above instructions. Any request for leave during the said period shall not be entertained, except in exceptional circumstances and with the prior approval of the Competent Authority, subject to the directions issued by the District Commissioner & Principal Census Officer, Jorhat.

3. यह आदेश तत्काल प्रभाव से लागू होगा तथा अगले आदेश तक अथवा जनगणना 2027 के पूरा होने तक, जो भी पहले हो, प्रभावी रहेगा।

This order shall come into force with immediate effect and shall remain in force until further orders or completion of the Census 2027, whichever is earlier.

O R D E R

As per Circular No. 15 of CENSUS-2027 all Heads of Department of Jorhat District are hereby directed to inform all Officers and Officials under their administrative control any Census Officer Lawfully required to give assistance towards taking of census who refuses to perform any duty imposed upon him/her by this Act or any Rule made there under, or any person who hinders or obstructs another person in performing any such duty or neglects to use reasonable diligence in performing any duty imposed upon him/her or in obeying any order issued to him/her in accordance with the Census Act, 1948 or any rule made there under shall be punishable with fine which may extend to one thousand rupees and in case of conviction shall also be punishable with imprisonment which may extend to three years under section 11(1)(a) and section 11(1)(aa) of the Census Act,1948.

Further, all Head of the Departments are also directed that the Officers/Officials who are nominated/engaged in Census duty for Houselisting and housing Census (HLO)-Phase:1 of Census-2027 should not be granted any kind of leave (CL,EL,CCL,etc) without prior approval of the undersigned.
