Sir/Madam

Hon'ble Minister (EF&CC) has observed that most of websites/portal under the Ministry are secured and having no SSL Certificates, no social media accounts. Hon'ble Minister (EF&CC) has directed for immediate action for the following:

(i) All Divisional Heads who have created/managing separate web portals and all Heads of Organizations under MoEFCC are requested to get the SSL certificate immediately and ensure their website/portals are secured. The SSL Certificates are available in GeM Portal.

(ii) All organizations under this Ministry should create social media accounts (Twitter, Facebook, YouTube, Koo, Flickr etc.) and provide link of the same in their respective websites/portals.

(iii) All the Tweets of the Ministry and other organizations of the Ministry should be retweeted from their respective Twitter handles and also to share other social media posts for wider outreach and publicity.

(iv) All Divisional Heads and Heads of Organisations under the Ministry to send videos and photos to enable Media Division to create a repository for creating infographics for the use in the social media platforms.
